Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. An unpaid direct debit as at the year end has been incorrectly included as an item of expenditure in the cash book and as a reconciling item on the bank reconciliation. The figure in Section 2, Box 8 should read £932,892. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.
